

Washing Instructions:









Do not wash and bleach the gloves. Drying in tumbler is not possible. Do not iron. Professional dry and wet cleaning is not allowed.

Storage and aging:

Keep in a cool, dry place; do not expose to direct sunlight; keep away from any ignition sources; store in the original packaging if possible. The properties of the gloves will not change for a period of up to 5 years from the manufacturing date, provided they are stored as recommended. A precise service life cannot be stated, as it depends on the type of use and on whether the user ensures that the gloves are used exclusively for their intended purpose. The manufacturing date (month/year) is stated on the gloves.

Disposal:

Dispose of the gloves in accordance with applicable local laws.

Health risks:

Allergies, caused by the proper use of the gloves, are not yet known. If an allergic reaction still occurs, consult a doctor or dermatologist.
